

# **REQUIRED WAIVER AND EMERGENCY TREATMENT AUTHORIZATION FORM**

### EMERGENCY TREATMENT AUTHORIZATION

I/We the undersigned parent, parents, or legal guardian of a minor, do hereby authorize and consent to any x-ray, examination, anesthetic, medical or surgical diagnosis rendered under the general or special supervision of any member of the medical staf licensed under the provisions of the Medicine Practice Act or a dentist licensed under the Dental Practice Act and on the staf of any acute general hospital from the States of Minnesota or Wisconsin Departments of Public Health. It is understood that this authorization is given in advance of any specifc diagnosis, treatment, or hospital care being required but is given to provide authority and power to render care which the aforementioned physician in the exercise of his best judgment may deem advisable. It is understood that effort shall be made to contact the undersigned prior to rendering treatment to the patient, but that any of the above treatment will not be withheld if the undersigned cannot be reached.

## RELEASE

The undersigned parent/guardian recognizes that an element of risk is involved in all water sports, including sailing. Therefore, to induce the Saint Croix Sailing School to accept his/her child into the Saint Croix Sail- ing School, the undersigned parent/guardian covenants and agrees to hold harmless and indemnify the Saint Croix Sailing School, its ofcers, directors, employees, and agents from any and all claims, losses, damages, fees and liability growing out of or in any manner related to injury to a person or damage to any property arising out of or in any way connected with the operation of the Saint Croix Sailing School or any activities on or the use of any facilities or equipment of the Saint Croix Sailing School.

## CERTIFICATION OF SWIMMING SKILLS

I/We the undersigned parent, parents, or legal guardian, do hereby certify the child enrolled can swim unaided for 50 yards and tread water for one minute. All students will be required to pass a swimming test with life jacket on.

## PARENTAL AGREEMENT

I/We understand that I/we are responsible for our child's or grandchild's behavior and conduct while at the Saint Croix Sailing School and will see to it that our child adheres to the program rules. I/We agree to assume the obligation for expenses of repair and/or replacement of program equipment that is attributed to our child's reckless or irresponsible behavior and the expense of medical care if your child is injured. I/We agree to make an appointment for a parent/instructor conference if requested.

#### YOUTH OPTI AND 420 SAILING DISCLAIMER

Age as well as weight are critical determining factors in placing kids in the correct boat/class. The Saint Croix Sailing School reserves the right to move kids to diferent boats/classes if/as necessary to preserve safety standards. Kids older than 10 can continue in Opti classes if they desire but are encouraged to consider the Opti Race team if they are older than 10.

#### MEDIA RELEASE

In consideration of good and valuable consideration, the receipt of which is hereby acknowledged, I hereby grant to Saint Croix Sailing School, its licensees and assignees, the non-exclusive, perpetual, irrevocable and worldwide right to use, reproduce, edit, distribute, broadcast, display and/or exhibit through any and all media, audio, video, and photographic recordings of me, my child, my property, and/or my child's property taken during any and all registered sessions.
